Sub: Sanction of Grants-in-Aid to Dr. Nilesh Dipakrao Joshi, Assistant Professor, KCES College of Education and Physical Education, Jalgaon, Maharashtra for Publication- "Commonwealth Games and India" under the Scheme of Human Resources Development in Sports (HRDS)- Release of First installment- reg.

Sir,


I am directed to convey the sanction of President of India to payment of non-recurring Grants-in-aid of ₹2,56,560/- (Rupees Two Lakh Fifty Six Thousand Five Hundred Sixty Only) to Dr. Nilesh Dipakrao Joshi, Assistant Professor, KCES College of Education and Physical Education, Jalgaon, Maharashtra for Publication- "Commonwealth Games and India" under the Scheme of Human Resources Development in Sports (HRDS).

2. It has been decided by the Competent Authority to release non-recurring grant of ₹64,140/- (Rupees Sixty Four Thousand One Hundred Forty Only) as 1st installment (25%) to National Sports University, Manipur (CNA Agency-NSUSCHEME) and authorize CNA to set the drawing limit on PFMS portal to KCES College of Education and Physical Education as per revised procedure for fund flow under Central Sector Scheme to meet the expenditure for the Publication- "Commonwealth Games and India".

3. The grants-in-aid sanctioned herein will be drawn by Drawing and Disbursing Officer (Grants-in-aid) Ministry of Youth Affairs & Sports for the purpose on a GIA Bill before 31st March, 2024 for disbursement to the grantee through Cheque/ECS.

4. The release of ₹64,140/- (Rupees Sixty Four Thousand One Hundred Forty Only) to National Sports University, Manipur (CNA Agency-NSUSCHEME) and authorize CNA to set the drawing limit on PFMS portal to PIN KCES CLG OF EDU AND PHY EDU ZBSA as per revised procedure for fund flow under Central Sector Scheme is further subject to the following terms and conditions:-

- i. The grant should be utilized only for the purposes for which it is sanctioned and the unspent balance of grant, if any, shall be refunded by the grantee immediately after completion of the program.

- ii. The excess amount, if incurred, on the approved work over and above the grant released shall be borne by the grantee. In other words, no additional grant over and above the approved amount would be provided by this Ministry.
- iii. Assets acquired, wholly or substantially, out of Government grant, except those declared obsolete and unserviceable or condemned in accordance with the procedure laid down in the General Financial Rules (GFRs), shall not be disposed of without obtaining the prior approval of the Department of Sports, Ministry of Youth Affairs & Sports.
- iv. The accounts of the grantee shall be maintained in accordance with the provisions contained in General Financial Rules, 2017 as may be amended from time to time. The accounts of the grantee shall be open to inspection by sanctioning authority and audit, both by Comptroller & Auditor General of India under the provisions of the CAG (DPC) Act, 1971 and internal audit by the Principal Accounts Office of the Ministry of Youth Affairs & Sports, whenever the grantee is called upon to do so.
- v. The work should be published within one year from the date of award of the grant; the offer for the grant-in-aid will automatically lapse after one year unless the period is extended upon consideration of a specific request from the author or the publisher.
- vi. The title page of the publication should bear the following entry: "Published with financial assistance from the Department of Sports, Ministry of Youth Affairs and Sports, Government of India, vide sanction letter No. No.K-15015/7/2024-SP.V (31654) dated 14.03.2024.
- vii. This is non-recurring grant. The grantee shall submit a certificate of utilization of the non-recurring grant for the purpose for which it is being sanctioned in Form GFR 12-A. In addition, an audited statement of expenditure incurred on various components in connection with the work will be submitted to the Department of Sports, Ministry of Youth Affairs & Sports.
- viii. The grantee shall abide by the terms & conditions of the grant.
- ix. The grant is further subject to the conditions laid down in the GFRs, 2017 as may be amended from time to time.
- x. The grantee should also certify that it has not obtained or applied for grant for the same purpose or activity from any other Ministry or Department of the Government of India or any other Non-Governmental Organization (NGO) or voluntary organization.
- xi. The grantee shall ensure that the work is executed in accordance with the provisions of the Scheme of Human Resources Development in Sports (HRDS).

5. It is certified that no UC is outstanding against the Grantee under the HRDS Scheme.

6. The sanction is being issued in exercise of the powers delegated and in conformity with the rules and principles as approved by the Ministry of Finance. It is also certified that the pattern of assistance has the approval of the competent authority.

7. The Ministry of Youth Affairs & Sports will authorize to **National Sports University, Manipur (CNA Agency-NSUSCHEME)** to set the drawing limit on PFMS portal for further authorization of funds in its **HDFC Bank Account No. 50100584115729, IFSC Code - HDFC0005051**. Accordingly, the amount of **₹64,140/- (Rupees Sixty Four Thousand One Hundred Forty Only)** shall be electronically transferred to **PIN KCES CLG OF EDU AND PHY EDU ZBSA, HDFC Bank Account Number 50100712377952, IFSC Code: HDFC0000180**.

8. The grant of **₹64,140/- (Rupees Sixty Four Thousand One Hundred Forty Only)** will be debit to the Demand No. 102 – Ministry of Youth Affairs & Sports, Major Head "2204" – Sports & Youth Services, Minor Head "00.104" – Sports & Games, 63 – Assistance to




