Item No. 3: Under this item Dr. S. M. Labde chairman of BOS placed the proposal of the department for starting online C.Y.Ed. programme from the session 2020-2021. The course structure along with detailed syllabus reviewed by the BOS.

Resolution 3: It is resolved that online C.Y.Ed. programme of 5 credits (75 hrs.) as proposed by the department is approved along with the course structure and curriculum. It was discussed in the house to start C.Y. Ed. online programme for students, of UG and PG Programme as an optional subject in CBS from the session.

The BOS also recommended and directed the department to start one year online D.Y.Ed. (Annual) Pattern programme with the entry qualification HSC (12th Pass) which can be taken add-on with other regular programme for the benefit of students at large. The Head of the department & Chairman of BOS is empowered to prepare course structure, curriculum and detailed syllabus of D.Y.Ed. and start this programme from the session 2020-2021. It is directed to complete the procedure for starting of this programme immediately from the session 2020-21. The course structure, curriculum and syllabus shall be place for post facto approval of BOS in the next meeting.
